No deputy present for Buchanan County Deputy's Report. 31.67 hours of service were logged in February.

Roger Erickson, NRCS, and Jeff Tisl, Iowa Division of Soil Conservation, discussed options available for storm water mitigation outside the city limits. Both had received copies of the city's storm water study for review prior to meeting. No real funding is available through their departments for large projects. Mr. Erickson will send out letters on availability of money for construction of buffer strips. Participation from land owners is strictly voluntary and often difficult to get. Suggestions were to contact INRCOG, Iowa Flood Center, Northeast Iowa RC&D, and state/federal legislators for possible funding. Mr. Tisl would be willing to facilitate meeting between city and area land owners to discuss possibilities for projects.

Mike Hernandez asked that the council enter into an agreement for removal of flood debris and repairs (wash-outs) at his property if flood waters should overflow at the area which was lowered on Prospect Street. He further asked that any work be done after ground has dried so no damage would be done to yard. Agreement will be drawn up. He further recommended that the slopes along that area be reseeded since it does not appear the grass is growing and that a block wall be placed around the last remaining tree to prevent erosion. It was suggested that maybe it would be better to remove the tree. Kurt will inspect and make final determination.

Hearing for Budget FY16 was opened. Notice of proposed budget had been published according to law. No one appeared for or against FY16 Budget proposal. No comments oral or written were received. Fire Chief Terry Crow asked why fire budget was so much lower. It was explained that the fire department had spent its existing reserve on the tanker truck upgrade and bunker gear. Also the budget line items were lowered on possible grant money which inflates actual budget. Can be amended later, if necessary. There being no additional comments, motion made by Klingner, second by Haynes to approve the budget proposal for FY16. Aye: Dozark, Rawson, Wulfekuhle, Haynes, Klingner. Motion carried as Resolution 15-05.

Chief Crow gave a brief update on fire department training. BCEDC will be held in Lamont on April 28th and Leadership Training on March 26th. Flood plain permit application has not been filed with state for work at 640 Pine Street. No progress on nuisance abatement at 675 Concord Street. Mayor and city clerk had telephone conference with INRCOG for city's input on Buchanan County REAP Plan update. Council was asked to think about any other ideas which might be included.

Joe and possibly Terry will attend Lagoon Operations class in Fort Dodge on April 10th. Gary Reed will be contacted to see if he would serve as temporary affidavit operator for water and wastewater systems city after Kurt's retirement.

Motion by Rawson, second by Klingner to approve a \$1.00 per hour pay raise for Terry Crow who has earned the Water Treatment certification. Aye: Wulfekuhle, Dozark, Haynes, Klingner, Rawson. Resolution 15-06 was approved.

Draft of ordinance for minimum fee for water and sewer hookups to vacant properties was reviewed. Revision will be made to set parameters for what constitutes a vacant property.

Spring Cleanup has been scheduled for Saturday May 2nd. Council person Rawson reported that he had applied for two grants on behalf of the fire department. A Buchanan County Health Trust Grant for an AED (defibrillator) and the second to Walmart for a flat screen tv, projector, lap top computer with DVD to be used for training.

Motion by Wulfekuhle, second by Klingner to adjourn. Motion carried; all ayes. Meeting adjourned at 9:15 pm.
