Motion by Behrens, second by Devlin to approve the budget proposal for FY23. Ayes: Lamphier, Burington, Slack, Devlin, & Behrens. Motion carried as Resolution 22-09.

Fire Chief, John Cook, reported 5 medical, 1 fire, 1 car accident, and 1 controlled burn since last meeting. Nothing to report from BCEDC, Streets & Sidewalks, and Property Maintenance. Parks & Recreation reported bricks have fallen on sidewalk at City Park and Scout Park needs cleaned up. MR WMA reported that they are in Phase 2 of the higher risk projects and have hired a person to coordinate for six months. EMA/911 reported radios have been upgraded and a command trailer purchased. Public Works Director reported rock for campsites will be \$2200, switching to LED lighting for six city-owned street lights will be \$285.00 each, and waiting on start switch for well repairs. Bacteria samples were good. Council will look into grants for LED lighting.

Motion by Burington, second by Lamphier to approve Resolution 22-12 setting employee compensation for insurance. All ayes; motion carried.

Motion by Devlin, second by Behrens to follow the ordinance regarding the water leak at 621 Bush Street. All ayes; motion carried.

Motion by Devlin, second by Slack to send City Attorney updated Nuisance Abatement Procedures for legal approval. All ayes; motion carried.

Traffic Speed Cameras and Radar Enforcement to curb speeding on city streets was tabled. Electric Franchise Ordinance was tabled until next meeting with Alliant Energy representative.

Motion by Lamphier, second by Devlin to accept the resignation of Brian Lau as compliance officer effective immediately. All ayes; motion carried.

Motion by Burington, second by Devlin to adjourn. All ayes; motion carried. Meeting adjourned at 8:24 p.m.
