Motion by Behrens, second by Devlin to amend Resolution 22-33 Selling City Owned Property at 330 Pine Street to G5 Properties LLC directing Mayor and Clerk to issue a warranty deed and abstract. Ayes: Lincoln, Slack, Devlin, & Behrens. Motion carried as Resolution 22-35.

Fire Chief Cook reported the fire department had been on two fire, four medical, and one car accident since the last meeting. Mayor Dozark had attended the BCEDC meeting at Aurora where discussion was on daycare in Independence.

Streets & Sidewalks reported a concern about the extension cord on the Concord Street sidewalk. Councilperson Behrens will look into it. Parks & Recreation questioned the drop cords at the Scout Park for Santa Visit. Mayor Dozark said they would be picking those up. Nothing to report from Property Maintenance or MR WMA.

Public Works Director turned in his resignation. Council set a special meeting for December 21st at 7:00 pm. to discuss the vacancy. Quality Flow will be servicing pump at lift station. Oasis was in town to jetty Washington Street sewer main.

IMWCA Site Visit was discussed. Motion by Behrens, second by Devlin to approve and implement the Seatbelt/Restraint Policy required by IMWCA. Ayes: Slack, Lincoln, Devlin, & Behrens. Motion carried as Resolution 22-36. It was also noted that all places of employment, passageways, storerooms, and service rooms will be kept in a clean and sanitary condition with priority being given to the public works building.

Motion by Slack, second by Lincoln, to certify delinquent city service bills to property taxes for collection. All ayes, motion carried as Resolution 22-37.

Fire Chief Cook presented information on emergency response services to a confined space emergency at Innovative Ag Services located at 1760 Washburn Avenue. Fire Department will be meeting with IAS Representatives and Buchanan County EMS.

Council discussed amending Chapter 50.05 – Nuisance Abatement adding penalties of \$200.00 after 21-day grace period 1st Offense; \$250.00 after additional 7-day grace period 2nd Offense; \$300.00 for 3rd and Subsequent Offense. At 3rd offense, the City will take legal action to abate property and charge \$100.00 per hour, per worker to clean up and rectify the nuisance. First reading of this amended ordinance will be at the January meeting.

FY24 Budget was tabled until January meeting since property valuations were not available.

Motion by Devlin, second by Behrens to adjourn. All ayes; motion carried. Meeting adjourned at 8:08 pm.
