Deputy Tyler Klenzman reported the Buchanan County Sheriff's Department logged 32 hours during November with calls for service being dog complaint, fire, theft, and welfare check.

Public Works Director reported tractor was repaired and ready for more snow and looking for more lights for the tree. Fire Chief Crow reported the fire department had been on 1 medical, 3 lift assists and 1 controlled burn request since the last meeting. He also said Rick Wulfekuhle, Emergency Management Coordinator for Buchanan County Emergency Management Operations Center was retiring on December 12th. Mayor Cook reported an ambulance page order change for first call to Regional Medical Center had been made. Scout Park is now officially part of City of Lamont properties.

Motion by Slack, second by Devlin, to certify delinquent city service bills to property taxes for collection. All ayes, motion carried as Resolution 25-22.

Motion by Slack, second by Lamphier to approve Resolution 25-23 authorizing signatures on warrants. Ayes: Adams, Devlin, Lamphier & Slack. Motion carried.

Discussion was held on FY27 budget requests. City Clerk reported FY26 shows a 2.1% decrease in local option sales tax so need to budget less around \$54,000. Road Use Tax per capita forecasts is \$140 but Iowa Dept of Management recommends budgeting less which would be about \$58,000.

Mayor Pro-Tem Devlin gave the Oath of Office to Mayor-elect, Mike Cook. Mayor Cook gave the Oath of Office to Council-elects, Jarrod Lamphier and Mike Slack.

Motion by Lamphier, second by Adams to adjourn. All ayes; motion carried. Meeting adjourned at 7:20 pm.
